**INFORMATION REGARDING GOODS CARRIED IN TRANSIT OR EXPORTED TO
THIRD COUNTRIES AND TRANSPORTED THROUGH THE RUSSIAN FEDERATION
AND/OR BELARUS**

Dear Colleagues,

Please be informed that in order to more effectively prevent the circumvention of international sanctions, the Lithuanian Customs introduced strengthened control measures as of 5 June 2023. The European Commission and the EU Member States were informed about these measures by a letter dated 19 May 2023 No. (1.50Mr) 3BE-3972. Nevertheless, statistical data indicate that parallel import of some goods to Russia and Belarus continues to take place and it is necessary to prevent such circumvention of sanctions more effectively by involving into this process the business community, which through internal self-control procedures can ensure greater transparency throughout the supply chain from the producer to the final consumer.

In view of the above, please be informed about the change in the customs clearance procedure that will be applied by the Lithuanian Customs as of **3 July 2023**, namely, the requirement to additionally submit the manufacturer's declaration to the Lithuanian Customs when goods listed in the Annex to this letter are exported from the EU to the third countries or when in transit through the EU are transported in transit through the Russian Federation and/or Belarus.

This requirement will be applied by the Lithuanian Customs from **3 July 2023** for export and re-export declarations, and from **17 July 2023** it will be applied by customs offices operating at the border crossing points acting as customs offices of exit or destination.

Persons directly or indirectly involved in the customs clearance of these goods will be required to provide the Lithuanian Customs with a document issued by **the manufacturer of the exported (re-exported) goods** confirming the following information:

1) the manufacturer of the goods is aware of the seller and the buyer of the goods that have been sold and the transaction does not give rise to concerns about the possible circumvention of international sanctions;

2) the manufacturer of the goods is aware that the goods produced will be transited by the buyer/exporter through the territory of Belarus and/or the Russian Federation to a third country, and the manufacturer has no objection to this transportation;

3) the manufacturer of the goods is aware of the end-user and end-use of the goods, and the manufacturer of the goods can ensure that the goods will not be used in a manner inconsistent with the terms and conditions of international sanctions.

Please note that if the said document is not presented to the Lithuanian Customs, the goods will not be released from the European Union. Furthermore, in case of reasonable doubt as to the authenticity of the document submitted and the correctness of the information contained therein, the Lithuanian Customs will contact the competent authorities of the manufacturer's country to verify the document submitted and the information contained in it.

With this in mind, we kindly ask You to inform economic operators about additional control measures to be applied in Lithuania and on its borders with the Russian Federation and Belarus as of **3 July 2023**.
